CHC33021 Certificate III in Individual Support (Ageing and Disability), also commonly known as the Aged Care Course or the Disability Course, is suitable for individuals who want to obtain the latest nationally recognised qualification for caregivers and support workers and develop their career in the Aged and Community care sector.

There are no pre-requisites required to enter this training program SIT50422 Diploma of Hospitality Management. However, Vigil International College screens learners according to the following criteria:

- ✓ Occupational English Test (OET), Ibt, Pearson Test of English, Cambridge English Advanced with scores equivalent to IELTS 5.5 and no less than 5.0 in each band.
- ✓ The English test must have been taken within two years before the application is made.

Training and assessment information

This course is delivered face-to-face in a classroom-based setting, as well as through structured self-study.

The timetable for this course will be advised in your Offer Letter and Student Agreement. You are required to attend classes for 14 hours per week, as well as complete 6 hours of structured self-study per week for 40 study weeks (4 terms of 10 weeks each). Holiday breaks are as indicated in your timetable.

Class sessions include a mix of theory and practical activities with a focus on creating a real-life workplace. In addition to classroom based learning and structured self-study, you will also need to complete approximately 5 hours of additional, unsupervised study per week including general reading and research for assessments

Work Placement

A total of 120 Hours of mandatory industry work placement is required to be completed for this qualification.

Generally, you will be responsible for finding a Vocational Placement provider. However, you may be supported by the Vocational Placement Coordinator in finding one. The Training Manager and Work Placement Co-ordinator will discuss the best options for placement with every student to find a location and timing that suits the student. Where the student is already working in an appropriate Aged Care Facility, it is recommended that this facility would be best for gathering the workplace evidence for the units across the identified 120 hours. There may be some flexibility in the timing of workplace evidence collected for these existing workers who have employer support for this course.

Vigil International College will provide all work placement support resources to our students.

Work Placement Requirements:

All students entering a workplace facility in the aged care industry, must have:

- ✓ A satisfactory National Police Clearance
- ✓ Current Vaccination/Immunization Certificate and Proof of Immunity (Highly Recommended).
- ✓ First Aid Certificate (HLTAID011 Provide First Aid): This certificate is not included in the course. However, our sister college, Vigil Training College offers this course.

Student may need to get the manual handling certificate depending on their workplace requirements.

Course Progress and Attendance

Satisfactory course progress and attendance is very important in order to meet visa requirements.

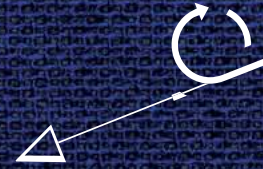
